How does our website use cookies?

- 1) Our website may place and make available certain first party cookies on your computer or device. First party cookies are those that were placed directly by Us and that are used only by us. We use cookies to enable and improve your experience with our website and to enable Us to provide and develop Our services. These cookies have been carefully selected by us. We have taken steps to ensure that your privacy and personal information is protected and respected at all times.
- 2) By using our website, you may also receive certain third-party cookies on your computer or device. Third party cookies are those placed by website, services and/or parties other than Us. Third party cookies are used on our website for website analytics and advertising services. Please see the section below for more detailed information.
- 3) All cookies used on our website are used in accordance with applicable laws. We may use some or all of the following types of cookies:

a) Necessary cookies

Cookies falls into this category if it is necessary for the smooth operation of our website and supports functions such as logging in or completing payment transactions.

b) Analytical cookies
